

1. Notice is hereby given that the National Company Law Tribunal, New Delhi Bench-V, has ordered the commencement of a corporate insolvency resolution process of the M/s Atul Vatika Developers Pvt. Ltd. on 11/10/2019.
2. The creditors of M/s Atul Vatika Developers Pvt. Ltd., are hereby called upon to submit their claims with proof on or before 09/02/2020 to the interim resolution professional at the address mentioned against item 10.
3. The financial creditors shall submit their claims with proof by electronic means only. All other creditors may submit the claims with proof in person, by post or by electronic means.

The claim may be submitted in their specified forms. **FORM B** - Proof of claim by operational creditors except Workmen and Employees; **FORM C** - Submission of claim by financial creditors; **Form CA** - Submission of claim by financial creditors in a class; **FORM D**- Proof of claim by a Workman or an Employee; **FORM E** - Proof of claim submitted by authorised representative of Workmen and Employees; **FORM F** -Proof of claim by creditors (Other than financial creditors and operational creditors.
